- 5. Storage sheds
  - a. New storage sheds has been purchased to replace the broken one and an additional one for lost and found.
- 6. Pool Room
  - a. Pool room has been cleaned and organized.
- 7. 1304 Blue Sky Way has been informed of removal of concrete slab (not approved by the City) per Fred.

#### New Business:

- 1. Hiring process
  - a. Moving forward, Yanneli and Gary will be working together as staff and board member when hiring new staff, as well as hiring of outside contractors for repair work. Work that requires bids and board approval will still run through the board and voted on appropriately.
- 2. Commercial picnic tables for pool area
  - a. Cheyanna proposes to replace the green tables with picnic tables and umbrellas for the pool area. Gary seconded, Scott approved, Paul votes no. Passed with majority vote.
- 3. Cameras

- a. Pending new quote for better cameras and find out what services we are paying for through SOS Alarm.
- 4. Landscaping
  - a. RV/Storage Unit has been completed.
  - b. Gebhard roadside clean up completed.
  - c. Easement area to be completed 5/15, only entry way was being done. Not the back area.
- 5. Bulletin Board
  - a. Now installed and information about the pool, office closures, and newsletters have been agreed upon to post. This will not be used for basic communications of yard sale, lost pets as this is to inform residents of HOA updates/business.
