Old Business:

- 1. Parking issues on Lara
 - a. Issue of moving a vehicle 3' skirt the rules is an issue as well as disabled vehicles. Paul proposes \$100 daily fine for inoperable vehicles. Cheyanna proposes that we first send a letter to the homeowner, giving them the opportunity to bring the vehicle down and prove that it is operable, or be fined. Yanneli proposes to bench this until we can get further guidance from the attorney. Issue is benched until further notice.

2. Play Structure

- a. Residents to vote on the playground. CC&R's state we can vote by proxy, slide is out of compliance and must be removed. Remove or replace old structure votes shall be sent to all homeowners and can be dropped in the lockbox. Must include name and signature.
- b. Yanneli will also reach out to the attorney regarding legal options to replace the structure without consenting vote.

3. Pool Issues

a. Pool needs depth markings around the dock- Mike will paint these. As of December, have not been painted.

- b. Solar heating pump was serviced by Solar Collection, pump is bad and took out the relay in the controller as well. Yanneli wil message Eli to see if he recommends anyone else for service since she has not heard back from Solar Collection.
- c. Yanneli to have this resolved and coordinated by the Spring.
- 4. Fence around A/C unit
 - a. Approved back in November but proposal was not signed.
 - b. Bush will need to be removed by the landscaper.
 - c. Fred motions to approve proposal and removal of bushes through Mando's Landscaping, Paul seconded. Motioned passed by Cheyanna. Proposal signed. Yanneli to coordinate scheduling for this.
